## ELECTRIC VEHICLE SUB-METER SERVICE (PILOT)

# Availability:

This schedule is available on a limited and voluntary basis for residential members at permanent locations where a leased or owned "plug-in" electric vehicle could be regularly charged. Conventional gas/electric hybrid vehicles which only use the engine to re-charge the battery are excluded. The battery size on the "plug-in" electric vehicle must be 4 kWh or larger and the vehicle must have at least four wheels and be manufactured primarily for use on public streets, roads, and highways.

This is a secondary meter and rate schedule designed to be used in coordination with a primary residential rate schedule. This rate schedule is applicable only to the meter associated with a secondary service dedicated to the installed electric vehicle charging equipment.

Determination of availability is at the discretion of the Cooperative and the Cooperative reserves the right to request additional information if clarification is necessary for such determination. This schedule is not available to any permanent locations currently being served with a sub-metered service or one that utilizes net metering or a dual-meter set-up for renewable energy generation. This schedule is also not available to consumers with a prepaid metering contract.

The number of individuals participating in this sub-metered service pilot will be limited by the number of individuals participating in the time-of-use rate pilot and the cap on the number of participants for both rate pilots will be approximately 25, with the final number of participants subject to the discretion of the Cooperative.

The intent of the rate is to provide an incentive for the charging of a "plug-in" electric vehicle during the Cooperative's off-peak times for a discount. To qualify, applicant must provide the following: Electric vehicle registration card corresponding to associated service address with the Cooperative Proof the vehicle can be recharged from an external plug-in source of electricity Notify Cooperative if ownership or lease of the electric vehicle changes while on this rate

#### Membership:

Each consumer receiving service under this schedule shall be a member of the Cooperative, comply with the bylaws, and abide by all service rules and regulations as adopted by the Cooperative's Board of Directors.

#### Type of Service:

The Cooperative will furnish 60-cycle service through one meter at the following approximate voltages where available:

- Single-phase, 120/240 Volts, or
- Three-phase, 208Y/120 Volts, or
- Three-phase, three wire, 240 Volts

Prospective members should ascertain the available supply voltage by contacting the nearest Cooperative office before acquiring equipment.

This sub-metered service will be available during the entire year, however, there will be different charges for the energy consumed from the electric vehicle charger sub-metered service based on the time of year.

#### Critical Peak Hours:

The Critical peak hours will be Monday – Friday from noon to 6:00 P.M. during the months of June through September, excluding those holidays designated by the Cooperative.

# Off-Peak Hours:

All other times excluding Super Off-Peak hours All hours for the following holidays: July 4 and Labor Day

#### Super Off-Peak Hours:

Every day from 10:00 p.m. to 5:00 a.m.

# Wholesale Power Cost Adjustment:

The above charges per kWh will be increased or decreased by 0.00001 cents per kWh or major fraction thereof, adjusted for line loss, by which the Cooperative's cost of purchased power per kWh exceeds or is less than Factor B of Schedule 8.1 - Wholesale Power Cost Adjustment Clause.

## **Capital Credits:**

Revenue received in excess of the cost of operating the Cooperative to provide service to members billed under this schedule shall be allocated to each member at the close of each fiscal year based on the member's contribution to the distribution margin as provided in the Bylaws.

## **Contract Period:**

The original term of service under this rate shall be one year and thereafter be terminated by either party on thirty days written notice.

#### North Carolina Sales Tax:

The above rate does not include N. C. sales tax. Any applicable sales tax will be computed and included on the bill.
