**SCHEDULE OL – OUTDOOR LIGHTING SERVICE**

Availability:

Available for dusk to dawn outdoor lighting service to all members where the Cooperative’s distribution facilities are located. Not available for part-time or seasonal operation of luminaires.

Membership:

Each consumer receiving service under this schedule shall be a member of the Cooperative and agrees to comply with the bylaws and abide by all service rules and regulations as adopted by the Cooperative’s Board of Directors.

Monthly Rate:

All-night outdoor lighting service using underground conductors and Cooperative’s standard equipment mounted on wood poles, unless noted otherwise.

Notes:

1. "Existing Wood Pole" monthly charge is for a fixture hung on an existing pole already in use.
2. For poles taller than 35 feet, add \$4.84 per month.
3. Underground service will be run up to 200 feet. Thereafter a one-time charge of \$4.00 per foot will be added.
4. For municipal lighting installations with an outlet, a \$2.00 per luminaire charge will be added to the monthly charge in order to accommodate this feature.

Payment:

Bills under this schedule are net and are due and payable at the office of the Cooperative when the bill is rendered. Bills are considered past due after twenty-five days and service is subject to be disconnected after due notice. A deposit as specified in the Cooperative's Service Rules and Regulations may be required.

Wholesale Power Cost Adjustment:

The above charges per kWh will be increased or decreased by 0.00001 cents per kWh or major fraction thereof, adjusted for line loss, by which the Cooperative's cost of purchased power per kWh exceeds or is less than Factor B of Schedule 8.1 - Wholesale Power Cost Adjustment Clause.

Capital Credits:

Revenue received in excess of the cost of operating the Cooperative to provide service to members billed under this schedule shall be allocated to each member at the close of each fiscal year based on the member's contribution to the distribution margin as provided in the Bylaws.

Other Installations:

Luminaire installations of a type other than those above can be installed on request, at the Cooperative's option, at the rate above for a luminaire of equivalent rating plus an extra monthly charge of 1.5% of the difference between the estimated installed cost of the luminaire and structure requested and the estimated installed cost of the equivalent luminaire and structure above.

Explanatory Notes:

The Cooperative will maintain the luminaires during regular working hours as soon as practicable following notification by the member of the necessity. All facilities necessary for service under this schedule shall be owned by the Cooperative.

Location of the luminaires shall be designed by the member; however, this schedule provides for no more than one new span of secondary line and pole per luminaire.

North Carolina Sales Tax:

The above rate does not include NC sales tax. Any applicable sales tax will be computed and included on the bill.
