Brighter Future Renewable Rider

RIDER BFRR

Availability:

This Rider is available on a limited and voluntary basis to local governments and institutions of higher education (qualifying member) within the Cooperative's service territory to meet renewable energy sustainability goals. This Rider will apply to units of solar energy, contracted in 100 kWh blocks ("Solar Blocks") sold to the qualifying member by the Cooperative from energy produced by designated solar generation resources of the Cooperative.

The allowable number of Solar Blocks for purchase by the qualifying member will be determined for each metered account of the qualifying member at the level that the Cooperative determines is not expected to exceed the account's metered kWh usage in any month. Should the number of Solar Blocks purchased under this Rider exceed the account's metered kWh usage, there will be no credits or refunds issued by the Cooperative. With at least thirty (30) days' notice: the qualifying member may elect to increase the number of Solar Blocks purchased, provided the specified accounts' monthly usage supports the additional Solar Blocks, and subject to Solar Block availability; or decrease the number of Solar Blocks purchased. If the qualifying member elects to decrease the number of Solar Blocks, the qualifying member subsequently will not be eligible to increase the number of Solar Blocks for a minimum of twelve months. The maximum number of accounts served under this Rider shall be determined by the maximum number of Solar Blocks available through the Rider.

Energy purchased and/or produced from designated solar generation resources will displace energy that would have otherwise been purchased pursuant to the Cooperative's then current wholesale power purchase agreement for all other load to members served by the Cooperative; however, such energy purchased from designated solar generation resources may not be delivered specifically to the individual member contracting for service under this program.

This Rider is not for temporary or resale service.

The provisions of the Schedule with which this Rider is used are modified only as shown herein.

Service rendered under this Rider is subject to the provisions of the Cooperative's Service Rules and Regulations on file with the North Carolina Utility Commission.

Monthly Rate:

In addition to all other charges stated in the Monthly Rate of the Schedule with which this Rider is used, the following charge shall apply to each Solar Block purchased:

\$ 1.90 per Solar Block

This Rider's Monthly Rate shall be applied to the regular bill for the account regardless of actual monthly kilowatthour consumption of the account.

Definitions:

- 1. Solar Block = 100 kWh.
- 2. Designated Solar Generation Resources For purposes of this tariff, the Designated Solar Generation Resource is Brighter Future Solar LLC. The Cooperative may add generation resources at its discretion.

Contract Period:

The initial Contract Period under this Rider shall be one (1) year. After the initial period, the qualifying member or Cooperative may terminate service under this Rider by giving the other party at least thirty (30) days prior notice.

Applicable Taxes:

The total charges under the Rider will be increased by any applicable sales taxes imposed by any governmental authority.
