## REBATE PROCESS

- Complete the rebate form.
- Submit the following information:
  - Completed rebate form; and
  - A copy of the detailed receipt.

## ELIGIBILITY

- Applicant must be member of record for an active Blue Ridge Energy account.
- Rebates are available for residential members only.
- Work must be completed by a contractor.
- Limit one rebate per measure, per account.
- Heating source must be electric.
- Home must be at least 5 years old.
- Insulation in floor/crawl space must be upgraded to R19 or greater.
- Insulation in ceiling/attic must be upgraded to R30 or greater.
- Failure to provide required information may result in denial of rebate.
- Blue Ridge Energy reserves the right to amend or discontinue this program without notice.
- Rebates are available for measures installed after May 1, 2016.
